- 8) we inform You that, with respect to the treatment in issue, you will be able to exercise the rights of which to the art. 7 of directive n. 196/2003, whose text is attached.

Art. 7 (Straight of access to gives personal and other rights to you)

1. The interested one has straight to obtain the confirmation of the existence or less than they give to you personal that regards it, even if not still records to you, and their communication in intelligible shape.
2. The interested one has straight to obtain:
  - a) of the origin of they give to you personal
  - b) of the finalita' and modalita' of the treatment;
  - c) of the logic applied in case of treatment carried out with the aid of electronic instruments;
  - d) of the ends identified to you of the holder, the responsables and the representative designated to the senses of article 5, codicil 2; e
  - e) of the subjects or the categories of subjects to which they give to you personal can be communicates to you or that they can come some to acquaintance in qualita' of representative designated in the territory of the State, of responsables or people in charge.
3. The interested one has straight to obtain:
  - a) the modernization, the rectification that is, when it has interest to you, integration of gives to you;
  - b) the cancellation, the transformation in anonymous shape or the block of give deal you to you in violation of law, comprised those of which the e' necessary conservation in relation to the scopes for which they give to you they have not been collected or subsequently deal to you;
  - c) the attestation that the operations of which to letters to) and b) have been capacities to acquaintance, also as far as their content, of those people to which they give to you has been communicates to you or diffuse, eccettuato the case in which such implementation it is revealed impossible or it involved a means employment manifestly without proportion regarding the protected right.
4. The interested one has straight to oppose, in all or part:
  - a) for legitimate reasons to the treatment of they give you personal that regards it, ancorche' pertinenti to the scope of the collection;
  - b) to the treatment of they give to you personal that regards it to fine of shipment of advertising material or of direct selling or for the fulfillment of communication or market researches they trades.
